Worth Considering:

The biblical message of Law and Gospel should fill and shape our approach to evangelism.

Certainly it should shape our evangelistic message, ruling out the works-righteousness that comes with synergistic approaches that ask people to make decisions for Christ and so forth. As Synod evangelism executive Erwin Kolb wisely used to say, people will try to stay with Christ the way they think they first got to Him. If they think they first got to Him in part by their own effort, they will keep on making such efforts. These will never be enough, and they will never be good enough in the sight of God. The Law cannot save a sinner. Only God in Christ can do that. He does it through the message of the Gospel, the power of God unto salvation.

But not only should Law and Gospel fill and shape our evangelistic address, as it were; in due distinction, they should also fill and shape our approach to evangelism. Why engage in it? Why does the church do this? And why would I be involved? Law plays a part in the answers to questions like these, yet certainly not only Law.

Toward the end of a recent workshop on evangelism in our District, a young pastor very politely made an important observation. He noted that we had talked for quite a while basically about ways and means – that is, about the *how*. He appreciated that, and he said absolutely nothing against it. Still, he did not think it would be good for the time to end without a word about the *why*.

Gentle rebuke duly noted! For it is important also to say what the Lord is doing through His church in evangelism. We want to move Christians toward evangelistic involvement, and to do so evangelically.

For years I have told a story from when I was much younger, listening as an evangelism leader said that he used to motivate people for evangelism by the Law. As he characterized it, he used to tell them they had to get out there and do it. They had to. They just had to. But this man went on to say that more recently he had started motivating people for evangelism with the Gospel he told them how to do it. Of course, telling people how to do something amounts to still more Law. It does not proclaim to them reconciliation and peace with God on account of the Christ Who lived and died for them and rose again. Now, I know that. Still, in an evangelism workshop I showed myself capable of gliding over the best part of the *why* for evangelism, Christ and the salvation He brings.

C.F.W. Walther said: "After a long season of sluggishness and lukewarmness, during which you began to hate yourself because you saw no way to change your condition, you happen to hear a real Gospel sermon, and you leave the church a changed man and rejoice in the fact that you are a child of God. You suddenly become aware of the fact that it is not difficult to walk in the way of God's commandments; you seem to walk in it of your own accord" (*Law and Gospel*, Dau ed., 384).

I still like an illustration I learned years ago. The Law is like a rudder that keeps a ship on course, but the Gospel alone can serve as the wind in the sails to move that vessel along. Like many other good works, telling the Good News about Jesus is something to which Christians need to be exhorted. There is nothing wrong with reminding God's people of their responsibility. But the power to meet the responsibility comes through the Gospel, not the Law. – Ken Schurb <u>kschurb@cidlcms.org</u>
