From the President's Desk

"Shall We Gather?"

In our topsy-turvy world, especially during the last eleven months, we have made do, with restrictions, quarantines, and governmental and health department dictates that have stretched the limits of our mental and spiritual wellbeing, and for some, due to the illness, their physical condition. Add media hype and manipulation, governmental overreach, political narrative, and personal fear to the mix and we have seen our lives and liberty stifled to a degree not experienced by most of our citizens in our lifetimes.

Gather with your fellow believers and draw from their Spirit-given strength and the encouragement of the Word of God.

While all this was going on, our little community, the Church, has carried on within these limitations and even ventured forth in new ways. A greater use of the Internet for live-streamed services has sent the Gospel out in ways we had not utilized as much or as often until now. Love for our neighbor in the pew kept our shared smiles under cover and held us at a distance, which affected our usual post-service fellowship and conversations. Shared snacks and meals became fewer and even the Lord's Supper, in some circles, was suspended for a time. Numbers of worshipers gathered on a Saturday or Sunday were maintained at extremely low levels of ten at first and only raised to 25% of capacity since mid-summer. It took a while, at least in our state, for our congregations' worship to be viewed

as "essential" by governmental standards. Pastors were extending themselves to the point of sheer exhaustion in order to provide the gifts that are exclusive to the Church to those eager to receive them.

There is now a new prognostication that with the present-time restrictions slowly going away, the vaccines being made available, still a new group is developing in our congregations who may now avoid public worship in the future because of the promise that doing so will keep them safe. This all over an illness that has a 98% survival rate. There are still fears of potential hospitalization, virus mutations, and long-time lingering after-effects. Some, we are told, enjoy watching the service on their computer screen, while sipping their coffee and eating their donut in their pajamas and remaining anonymous. They are still feasting on the Word, but is this the optimum for the children of the Lord?

Our loyalty to the Lord is always put to the test. Certainly, in our daily remembrance of His commandments and our evaluation of how well we are doing by them, we fall short in obedience but repenting, He never falls short in grace and pardon. In our knowledge of His Word, we don't know as much as we are known by Him. In self-justifying our actions according to the times and circumstances, He justified the world (declared us not guilty) by the shed blood of His Son which was not a convenience for Jesus but certainly worked out for our benefit. As far as worship attendance is concerned, statistically, we have seen a steady decline over the last half of the twentieth century and into the 21st, so that now we should rejoice that 20% of the membership is in church when things are good and not so scary. A steady increase in those who are determined to have nothing to do with Christianity or the Church (the non-affiliated) has been seen since the beginning of the new century.

Those still a part of the worshipping community should recognize the benefits that should draw us to a greater participation as the opportunity lends itself. *There are privileges that come with our membership!* Since the beginning, worship of God doesn't only take place on an individual basis as in our prayer conversations with the Almighty. The Church is a community on par with family and country. We step forward in our pilgrimage with fellow saints by our side who share our same experience in our heavenward trek. Encouraging takes place as they take hold of our hand on this same narrow pathway. In the Third Commandment we are called together "in holy assembly" to be taught and to hear, to meditate and to join in the mutual comfort and conversation of the brotherhood. We are told not to forsake the "assembling of ourselves together," because even "where there are two or three gathered in His name, the Lord is in our midst." We offer up prayers for ourselves and for one another as an exercise of love that can never take place in isolation. The Church is community! The Word is communal, the sharing of the Gospel is communal, the washing of water and the Word takes place as a communal act, and the body and the blood of Jesus in the Sacrament is never isolated from the fellowship of the Church. It is a communal meal, an expression of our common faith, our common participation with God and with each other.

You can find resources that survey the Old Testament in a year. Here, however, is one that does so in a *church year*. Going through Old Testament history in chronological order, it correlates various Old Testament incidents with the church year's themes and emphases.

This audio resource will consist of a series of *Issues, etc.* interviews with CID staff member Ken Schurb during the 2020-2021 church year. The typical interview will run about 25 minutes, closer to 20 minutes if listeners fast-forward through various announcements. The interview recordings will be available on demand at <https://issuesetc.org/archive>

The series commenced on Thanksgiving Day, November 26, 2020, with an hour-long premiere highlighting the biblical teachings of Creation (appropriate for Thanksgiving) and of the Fall and first prophecy of the coming Deliverer (for the First Sunday in Advent). In each succeeding week, God willing, you will find at least one interview, occasionally more than that, to unfold the story of the Old Testament through the church year. The series will end on the Sunday before Thanksgiving in 2021.

After listening to each of these interviews, you can ask yourself:

1. **Now, how did that go?** – What was the Bible story on which the interview centered?
2. **Now, what is the Lord saying to me?** – What was the Law in this biblical account? Where was the Gospel?
3. **Now, how does this apply?** – What applications to life did this interview state? Or which others might be suggested by it?

Listen for these interviews week by week. Dig into the Old Testament. At the same time, renew your acquaintance with and appreciation for the church year. It all centers in Christ!

Ramsey+

If you have heard of Dave Ramsey, you have probably heard of Financial Peace® University, and vice-versa. Mr. Ramsey has taught money management skills for some years now. Although he has a number of platforms, including his own radio program, until now Financial Peace® University has amounted to his main set-piece teaching tool.

By the way, the Stewardship page of our Synod’s website has for years featured a “Preview and Review of Financial Peace® University,” which offers helpful suggestions for Lutheran pastors and lay leaders who want to use that tool in their congregations. Ramsey+ also offers online support through a Facebook group, a free coaching session for those who have questions and are challenged to find answers, and access to various live-streamed events.

With a generous grant from the Church Extension Fund, the Central Illinois District finds itself in a position to purchase a one-year Ramsey+ subscription that will include a number of CID congregations. With this, a congregation could grant access to the entire Ramsey+ bundle of financial resources to every family unit within the congregation for that year.

Would your congregation be interested in availing itself of this opportunity? How much use would you make of Ramsey+ in a year? Would your congregation be willing to offer CID the sum of \$500 — not to pay for its own subscription to Ramsey+, but to help CID do something like this again in the future?

Mathilda-ness

During this 175th academic year of Concordia Theological Seminary, the GatePost presents a transcribed portion of a class taught by Dr. Harry Huth on the Lutheran Confessions, from the seminary's last year in Springfield (1975-76). Dr. Huth told his students:

When I used to have a stewardship program in congregations, everybody thought that I was probably going to talk immediately and initially about how they handled their pocketbooks. But I used to tell them this story in order to make my point. I would tell them about the kind of stewardship I was hoping they would learn by the grace of God.

There was a fellow who wanted to marry a girl by the name of Mathilda. His father asked him, "Well, why do you want to marry Mathilda?"

The son replied, "Well, the first obvious reason is because she's a girl" . . . The father replied, "There are lots of girls. Why Mathilda?"

"Well, Mathilda is a Lutheran girl, and you told us we should always marry in the faith," the son answered.

"You know, there's lots of Lutheran girls. Why Mathilda?" asked the father again.

"Well, Mathilda is a beautiful Lutheran girl," came the son's reply.

"There are a lot of beautiful Lutheran girls. Why Mathilda?" pressed the father.

"She's an accomplished, beautiful Lutheran girl," came the son's emphatic answer.

"There are a lot of accomplished, beautiful Lutheran girls," said the father. "Why Mathilda?"

The father kept plying him with that kind of question.

Finally, in utter frustration, the son exclaimed: "I want to marry her for her Mathilda-ness!" [transcribed by Rev. M. L. F. Freiberg, Sr.].

Only Mathilda could be Mathilda, and this young man knew it.

Camp CILCA "Life Changing, Life Long, Life Eternal" Campaign Update

In 2018 Camp CILCA launched the Life Changing, Life Long, Life Eternal capital campaign with the goal of raising \$1,000,000 to expand the Dining Hall, add a full time program director, eliminate debt, and add a significant amount of money to CILCA's endowment fund. The generosity of God's people abounded and two of these goals were met in full. The \$60,000 mortgage was paid in full and the endowment fund is up to \$100,000. The funds from this endowment go toward providing "camperships" for children who might not otherwise be able to afford a full week at camp.

While 2020 was a tumultuous year, CILCA was able to break ground on the Dining Hall expansion in September. As of January 11, the exterior frame is nearly completed and interior work continues. With the Lord's blessings the work will be completed by spring. Once the Dining Hall is completed the program director position will become the next priority.

Our Lord has been truly generous and His grace has made this all possible, working through His people. "Thank you" to all who have prayed, donated, and volunteered. You are a gift from the Lord.

Keeping Christ on Campus

College is tough. People need Jesus. Won't you help?

The *Keeping Christ on Campus* initiative is actively growing four campus ministry endowment funds created last year by Lutheran Legacy Foundation. What's more, Lutheran Legacy has generously offered to match 100% contributions to each of these funds, up to \$10,000 apiece, through July 1. Earnings from these endowments will help the Central Illinois District maintain ministry to the students, faculty, and staff of the University of Illinois, Illinois State, Eastern Illinois, and Western Illinois.

Campus Ministry Endowment Update: as of the middle of January, donations (NOT including matching funds) are as follows – U. of I.: \$10,450.75; ISU: \$8,296.75; EIU: \$4,025.75; WIU: \$9,320.75. As you can see, one of these endowments has already garnered over \$10,000, two others are approaching this mark, and the other is close to halfway there. **Thank the Lord for this early success!**

New Prison Ministry Coordinator Rev. Rodney Blomquist

The Central Illinois District has welcomed help as it seeks to expand prison ministry. Rev. Rodney Blomquist, who is retiring as pastor at Trinity Lutheran Church, Taylorville, has agreed to serve as CID's Prison Ministry Coordinator.

Rev. Blomquist has a wealth of personal experience in prison ministry. When the Taylorville correctional facility opened in 1990, he was among the first volunteers to conduct services and later a Bible study there.

Most recently, but prior to the current pandemic, he has taught a weekly Bible study and conducted chapel services on the fourth Sunday of the month at Taylorville. When there were confirmed Lutheran men in the facility, he has held monthly communion services for them.

He has also been involved in the "Storybook" project. Every other month, the men could record a book for their children or grandchildren. The recording as well as the book would then be sent to the appropriate child.

Rev. Blomquist's years of experience and depth of familiarity with Illinois prison procedures will benefit our District and many who will be on the receiving end of various outreach efforts that he coordinates. Pray for these efforts as they are getting started, and watch for further information about them in the weeks and months ahead!

CID Church Extension Fund

Grants Awarded in 2020

During 2020, God blessed the Central Illinois District Church Extension Fund (CID-CEF) to enable us to approve just shy of \$100,000 in grant requests with exciting possibilities for expanding the LCMS ministry both within and reaching beyond the Central Illinois District. The pandemic opened new opportunities for creative approaches to spreading the gospel! Following is a summary of the grants we approved during the year:



\$1,000 to Washington Our Savior – “Store to Door”

Shopping for those in the community who are unable to do so, while building relationships and sharing the Good News.

\$8,000 to Monticello Faith – “Vision for Honduras, Haiti, and Kenya”

Purchasing two autorefractors for prescribing eyeglasses to be used on evangelism and vision trips supplying 2,000 pairs of eyeglasses annually.

\$900 to Springfield Trinity – “Small Group Ministry”

Building small group relationships within the church and expanding to reach unchurched families and friends.

\$8,800 to Springfield Lutheran High School – “Live Streaming”

Live streaming activities such as chapel and athletic and musical events from the school while COVID restrictions prohibit attendance and posting on YouTube for greater outreach.

\$22,500 to schools throughout the CID – “Funding CID Schools Now and Forever”

Partnering with an anonymous donor and the Lutheran Legacy Foundation in year 2 of a 3-year program providing matching funds and grant funds to schools raising an initial \$5,000 endowment.

\$4,000 to Champaign University Lutheran – “Outdoor Tent for COVID Ministry”

Creating an outdoor space for student ministry and activities while providing great visibility to members of the community.

GRANTS to the Central Illinois District Office

\$10,000 to CID – “Parking Lot”

Third installment on refurbishment of the CID parking lot.

\$20,000 to CID – “Ramsey Plus Grant for CID Congregations”

Providing our CID congregations affordable access to financial tools including Dave Ramsey’s Financial Peace University.

\$4,000 to CID – “Reaching Out to Our Community Students and Families”

Producing a video for our schools as a recruitment tool highlighting their unique offerings during COVID and for the future, and hosting a training workshop on public relations and advertising/promotion.

\$4,050 to CID – “Peer Support Stipend”

Supporting the volunteer efforts of early childhood consultants, the prison ministry coordinator, and organists conducting clinics for other organists.

\$2,500 to CID – “Prison Ministry Video”

Creating a video to raise awareness of and recruit workers for the CID prison ministry.

\$2,700 to CID – “Circuit Events for Church Worker Recruitment”

Producing two videos during the Shelbyville/Effingham/Altamont joint Circuit Convocation focusing on church worker recruitment to be shared with other circuits in the CID.

\$7,500 to CID – “Seminarians in Need”

Providing needs-based support for seminary students.

We pray God’s Blessings on these ministry projects — may they enhance the spiritual life of our congregations and cultivate new believers for His harvest!

CID Endowment Fund

The Central Illinois District of the LCMS Endowment Fund promotes and encourages Christian Stewards through special gifts and bequests. These funds are used to further the Lord's work primarily in the area of scholarships for the education of full time church workers attending the Concordia University System, Concordia Theological Seminary in Fort Wayne, Indiana, or Concordia Seminary in St. Louis, Missouri, pursuing careers as ordained pastors or other full time church work professions.

The Central Illinois District Endowment Fund, Inc. was established for the solicitation, investment and disbursement of gifts, grants, devises and bequests to the Central Illinois District. It provides an avenue for the above gifts to be received and managed independent of the regular District budget.

The CID Endowment Fund was established by the CID at the 2003 District Convention. For many years prior to this the Clara and Spencer Werner Foundation provided financial support for CID students. The Clara and Spencer Werner Foundation encouraged the CID to establish this Endowment Fund. The Endowment Fund provides a vehicle for others to join in the funding of church worker education.

The CID Endowment Fund's Board of Trustees manages Fund assets and establishes policies for disbursement gifts. Congregations and individuals are asked to prayerfully consider giving generously to the CID Endowment Fund. Your gift, when combined with the gifts of others, will help the CID continue its support for those answering the call to serve His church.

The Endowment Fund was founded to assist the CID with scholarships for the education of full time church workers attending the Concordia University System, Concordia Theological Seminary in Fort Wayne, Indiana, or Concordia Seminary in St. Louis, Missouri, pursuing careers as ordained pastors or other full time church work professions. CID Church Extension Fund CDs were the initial funding method. The Endowment Fund Board determined the need for investment management and changed from exclusive investment in CDs because of changing economic conditions. The Fund also changed from reactive to proactive distribution of funds to the CID and established a distribution formula to inform the CID in February the funds available for the next academic year. This year's Scholarship Sunday is May 2, 2020.

Please consider additional gifts for scholarships by sending those funds to the CID Endowment Fund. With the current 4% of total plan assets going to the District for scholarships, your gift to the Endowment Fund will continue funding scholarships each year. Contributions to the Endowment Fund are deductible from income for tax purposes.
